

CLARIFICATION TEXT ON THE PROCESSING OF PERSONAL DATA

WEACCESS.AI Akıllı Çeviri Sistemleri Bilişim Anonim Şirketi

Some of your personal data are processed by WEACCESS.AI Akıllı Çeviri Sistemleri Bilişim Anonim Şirketi ("WeAccess.ai") as the data controller through the Portal serving through the domain name www.weaccess.ai and subdomain <https://pl.weaccess.ai/login> (Portal website, mobile site and mobile applications).

Clarification Text This clarification text has been prepared in accordance with Article 10 of the Personal Data Protection Law No. 6698 ("Law") and the "Communiqué on the Procedures and Principles to be Followed in Fulfilling the Obligation to Inform" in order to inform you about which of your personal data; for what purpose, how and for what reason it is processed, with whom it is shared and how long it is stored.

It is also important that you review the "Terms of Use", "Personal Data Protection Policy", "Cookie Policy" texts and the terms and conditions of the "Membership Agreement" on the Portal together with this clarification text.

Processed Personal Data

- If a real person registers as a member of the portal, identity information (name, surname, ID number); contact information (phone number, e-mail, address); personal information (tax number, company name) information is processed.
- If the portal is visited, transaction security information such as IP address information, website login and exit records of all visitors, whether they are members or not, are processed.
- If the portal is visited and a demo request is made, name, surname, telephone number and e-mail address information; if the contact form is filled out, in addition to these, data regarding the institution information and the content of the message written are processed.
- When our campus is physically visited, image data is processed through security cameras.
- Payment information of individuals is processed and stored by the Authorized Payment Institution established by Law No. 6493. WeAccess.ai does not store card information and other payment information in its own possession.
- In addition, cookies are used in the web version of the Portal, and you can review our Cookie Policy for personal data processed through cookies.
- Natural or legal persons who purchase WeAccess.ai software have the title of data controller in terms of personal data they process through the Portal. In this case, WeAccess.ai is in the position of data processor and ensures the protection of the personal data it learns with appropriate administrative and technical measures and does not use the personal data it learns for purposes other than processing.

Purposes of Processing Personal Data

- Carrying out customer relationship management processes regarding the products and services offered by WeAccess.ai,
- Follow-up of requests and complaints,
- Conducting communication activities,
- Contract requirements,

- It is processed limited to the purposes of providing information to authorized persons, institutions and organizations when required by the legislation.

Legal Reason for Processing Personal Data This personal data is processed in accordance with Article 5, Paragraph 2 of Law No. 6698.

- (f) (data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject).

Method of Collection of Personal Data Your personal data is processed partially automatically or automatically through the forms on the Portal, e-mail and other computer technologies based on the legal reasons stated above.

Transfer of Personal Data

- All personal data processed by WeAccess.ai as the data controller through the Portal are not shared with third parties other than the relevant public institutions, institutions and organizations in charge of auditing and inspection, and judicial authorities upon request.
- The personal data in question are not transferred abroad in any way. The relevant personal data is kept on servers located in the country.
- All processed personal data are kept for the period required for the purpose for which each data is processed by taking administrative and technical measures in accordance with the provisions of the KVKK.

"Pursuant to the Communiqué on the Procedures and Principles of Application to the Data Controller"; Data subjects must submit their requests in Turkish. Requests can be sent in writing to the address of the data controller specified below by hand, by registered mail with return receipt requested or through a notary public. Requests can also be submitted electronically signed via registered electronic mail (KEP) address or by using the electronic mail address previously notified to the data controller by the data subject and registered in the system of the data controller. Applications must contain the mandatory elements listed in paragraph 2 of Article 5 of the aforementioned communiqué. Otherwise, the applications to be made will not be evaluated.

- Applications duly submitted to us will be responded to as soon as possible and in any case within 30 (thirty) days at the latest.
